- 3) As payments will be made electronically, you have the option to choose to receive your payment via PayNow (which has to be registered with the recipient's NRIC) or Direct Credit to the recipient's bank account. To receive payment via Direct Credit, you will need to submit a copy of the front page of the bank passbook / bank statement.
  - (**Note**: For a payment request via Direct Credit to a joint or third party bank account, both the beneficiary and the account holder(s) must execute the indemnity form (Form 15) which is available for download at our website at <a href="https://pto.mlaw.gov.sg/deceased-cpf-estate-monies/forms/">https://pto.mlaw.gov.sg/deceased-cpf-estate-monies/forms/</a>.)
- 4) A declaration or testimonial from the proper authority giving details of the legal heirs of the deceased (if the deceased was not domiciled in Singapore)
